For UK start-up Avvoka we have supported the development of their contract automation tool that helps lawyers around the world to quickly and easily create sophisticated legal document templates. The tool uses a questionnaire to communicate with the client, from which it automatically adds relevant data to the documents. It allows online negotiation of the terms and details of the contract, ensuring that the other party does not make any changes without the user's knowledge, and includes a tool for in-depth analysis of the contract portfolio.

What was the challenge?

Before our partnership, Avvoka worked with an internal team of junior developers who had built an MVP (minimum viable product) of a documentation tool that could template contracts using intuitive automation. However, the team did not have the necessary experience for scaling the product for its commercial use. This is when we came into the picture with our expertise in building complex web applications and systems.

What was our solution?

At the beginning of our work, it was necessary to identify the product's key features and make a strategic plan for its further development. This way we could identify what pitfalls we may encounter and what are goals we want to achieve.

After clarifying these points, we assigned a team of experienced developers to the project with an ambitious task: to design and implement a completely new structure of consecutive processes and to create a product from Avvoka that will be commercially usable within the next few months.

Our philosophy of keeping the system simple and avoiding processes that are not necessary has proven to be correct. The first commercially usable version of Avvoka was developed within 4 months from the beginning of our cooperation.

We managed to develop three key functions for Avvoka:

Templating

The tool for creating document templates allows users to mark places in the text that need to be filled in by the client. Once the information is filled in - voilà, you have the first draft of the document.

If the user used Excel or another system to organize the data before Avvoka, it can be easily imported into the application.

Contract negotiation

If a multi-member is working on a case, the application allows all of its members to comment and edit the document simultaneously. After the final draft is prepared, the document is sent through the application to the counterparty, who has an opportunity to add his comments.

All changes and comments made by the counterparty during the negotiations are immediately apparent in the application. The user can accept, reject, or suggest further changes while tracking the history of changes.
